

Czech Association of Systemic Constellations (CASC) – Code of Ethics

1. COMPETENCIES

- ➤ The Facilitator makes sure that their level of facilitation experience and knowledge is adequate and in line with the needs of the Client.
- ➤ The Facilitator operates in their work only within the framework of their competencies.
- ➤ If the Client needs exceed the Facilitator competencies, the Facilitator guides the Client towards an expert with required competencies.
- ➤ The Facilitator is responsible for constantly upgrading their competencies in the field of systemic constellations through continuous learning, cooperation with other facilitators, participation at expert conferences and other similar events.
- ➤ The Facilitator strives to secure the highest possible level of quality in their work and constructive, developmental feedback through peer supervision.
- ➤ The Facilitator is open to cooperate with colleagues and experts from different fields of knowledge.

2. FUNDAMENTALS FOR RUNNING SYSTEMIC CONSTELLATIONS SEMINARS

2.1. The Request

- ➤ The Facilitator takes only positive Requests in the sense of a positive change in the Client position.
- ➤ The Request is given and the system is created only for the member of the given system.
- The Request regards directly only the client who requires the constellation. By setting up a constellation the Client doesn't try to influence a third party.
- The improvement in the Client position should not take place at the expense of someone else or through the excluding of someone else.



- ➤ The Facilitator pays special attention to creating and maintaining a safe space for all Participants during the Seminar.
- ➤ The Facilitator refuses to accept Requests if they feel that there isn't enough time to handle the Request properly.

2.2. The Role

➤ The Facilitator respects that people's participation in Roles is voluntary.

2.3. The Sentences

- ➤ The Sentences offered by the Facilitator to the people in Roles are conceived and handled as suggestions.
- ➤ During the formulation of Sentences the Facilitator takes into account the direct experience of the participants in Roles and avoids manipulation.

2.4. The Subsequent Care

- ➤ The Facilitator pays attention to creating sufficient space for reflection at the end of the seminar.
- ➤ The Facilitator pays attention whether the participants in Roles have properly de-rolled.
- ➤ The Facilitator gives participants their contact or contact to another person who could be addressed for subsequent questions and post-seminar care.
- ➤ The Facilitator has contacts to various experts in the topic of the Seminar. In case of need, the Facilitator shares such contacts with the Participants.

3. CONFIDENTIALITY

- ➤ The Facilitator retains confidentiality on all information received during individual or group work regarding participants, members of their systems and the system as such (family, organization, company etc.).
- ➤ The Facilitator cultivates confidentiality among seminar participants as well, including with people in Roles with regards to information received during the systemic representation of different people.
